### **From Your Steering Committee**

### **Tradition Eight**

## Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers.

The key to understanding this tradition is "Every time we have tried to professionalize our Twelfth Step, the results have been exactly the same: Our single purpose has been defeated."

The words...every time...not many or almost always...every time. And the words...exactly the same...the definition of exactly is "without discrepancy". This is the definition of insanity as described in Step One...doing the same thing over and over again and expecting different results. So at no point of professionalism does money and spirituality mix. This point was accepted with relative ease.

The contention surfaced when the discussion turned to paid jobs that happened to be within our offices or outside agencies dealing with the alcohol problem. There is a difference between the business of AA and AA's business.

Carrying the message of AA and doing Twelfth Step work does not fall under the definition of professional services and therefore should not be compensated. So when I answer phones at the Central Office I am carrying the message of Alcoholics Anonymous, which I do freely. However if I am a secretary at GSO, answering phones and performing activities that make Twelfth Step work possible, then compensation is appropriate.

The cautionary point for alcoholics who are working professionally in the field is to make sure they don't break the anonymity of Alcoholics Anonymous. My pride and ego must be checked at the door. I cannot think I know more or less than any other professional working in the field of addiction just because I am a member of Alcoholics Anonymous. Attaching Alcoholics Anonymous to my resume is a misuse of the name and a direct violation of the Eleventh Tradition, which protects the anonymity of Alcoholics Anonymous and all its members.

Questions: Do I try to sound in AA like an expert on alcoholism? Or recovery? On medicine? On sociology? On AA itself? On psychology? On spiritual matters? Or, heaven help me, even on humility?

### **Tradition Eight Checklist**

Alcoholics Anonymous should remain forever nonprofessional, but our services centers may employ special workers.

- Is my own behavior accurately described by the Traditions? If not, what needs changing?
- When I chafe about a particular Tradition, do I realize how it affects others?
- Do I sometimes try to get some reward-even if not money- for my personal AA efforts?
- Do I try to sound in AA like an expert on alcoholism? On recovery? On medicine? On sociology? On AA itself? On psychology? On spiritual matters? Or, heaven help me, even on humility?
- Do I make an effort to understand what AA employees do? What workers in other alcoholism agencies do? Can I distinguish clearly among them?
- In my own life, have I any experiences which illustrate the wisdom of this Tradition?
- Have a paid enough attention to the book Twelve Steps and Twelve Traditions? To the pamphlet AA Tradition-How It Developed?



### **Concept Eight**

The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporat- ed and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities.

Concept 8 addresses the potential dangers of too few people taking on too many tasks. Bill W. warned against "too much *concentration* of money and authority," based on early AA experiences.

The General Service Board is not directly involved in the daily operations of the General Service Office or AA publications. Instead, those tasks are delegated to others, such as the office manager. This allows the Board to focus on larger questions of policy, finance, group relations and leadership.

My husband and I watched a movie the other night called Woodlawn. It is a true story about a high school in the early 70's that is dealing with government mandated desegregation, a football team and a message of hope and love from a spiritual leader to the team that leads to a spiritual awakening that inspires the star player, his teammates and many members of the community to overcome the hate and anger that surrounds them. A comment was made near the end of the movie..."See what happens when God shows up!"

So I started to think about that and my Higher Power, whom I choose to call God. The tagline for me is "See what happens when I notice that God is here!" My God has always worked in my life. If He hadn't I wouldn't be a sober member of Alcoholics Anonymous today. I have ignored Him, walked away from Him, blamed Him, shunned Him, denied His existence at various times throughout my life. And yet here I am...some twenty-eight plus years later, sober and blessed by the daily Grace of a loving God.

Our literature tells me that the answer to all my problems is in my spiritual relationship with my God. It says I can go anywhere, do anything as long as I am in fit spiritual condition. I can navigate anything the world throws at me if I a willing to put my faith and trust in Him. The whole purpose behind the program of Alcoholics Anonymous is to develop a spiritual relationship with a Power greater than my-self.

I heard it said once that evil is not God's will...evil is the absence of God...the shunning of God. And even more profound than that is the fact that God wastes no tragedy...wisdom shared at a spiritual retreat I attended.

I think about what is going on in our world today...I have heard people say it must be really hard to get sober in these times. God has an incredible sense of humor...the technology that some say has separated and isolated us, has been a gift for so many in lieu of physical meetings. I was attending a virtual meeting the other night and 7 new people announced their desire to start their journey with us...I can't remember the last time I saw 7 people pick up desire chips at an in person meeting. And at the Intergroup meeting the other night after anniversaries had been announced, the Chair thanked them for showing us how to stay sober during a pandemic, much like the World War II test of the spiritual principal that is the foundation of Step Three (see page 38 in the Twelve and Twelve)

For me personally, I got to attend Founder's Day and the International Convention virtually. I got to attend a meeting in Australia...and can attend meetings anywhere in the world right now. I also started attending a Big Book study meeting out of Texas, which clearly explained to me the spiritual bankruptcy I experienced 2 years ago. I was attending meetings, sponsoring, doing service commitments... and yet did not feel any joy. What I have learned, is that I had abandoned my study of the Big Book and my focus on my conscious contact with God. So in the midst of a pandemic, I started to notice God again, stopped treating AA like entertainment and got back to the serious work of paying attention to the One who has always guided and protected me.

So I have experienced another spiritual awakening that has led me out of the depths of my selfinflicted despair back to the joy and delight that only comes when I notice that God is here!

### WRITING THE AMENDS LIST

Just after the finishing the Third Step Prayer, my sponsor, Carl, had me ask God for help with my Fourth Step information; this was simply praying to God to show me where I had been selfish, dishonest, resentful and fearful, then writing the answer as soon as it came from my deep inner self. (The Big Book mentions *"the Great Reality deep within"*—p 55) The Oxford Group—from hence came our Twelve Steps—called this practice *"Automatic Writing."* I added more information later from memory, but at first it had to be spontaneous. Once on this paper it could not be erased or altered, especially the harms I had done to others—not to forget employers, loan companies, etc.

About a week later, we were at Step Eight and much had been added to my list, especially from Step Five, thanks to my sponsor. The Step Eight information concerning the harms to others was right there on paper—remarkably simple—and there was no backing out!

Carl informed me that although I need to be willing to make amends to everyone on that list, there were certain amends that may harm others, and some may have been impossible to execute. What to do? I was told leave them on my Eighth Step list but be careful to follow the Big Book Step Nine instructions so as not to make another person's life troublesome. How to know? "God gave us brains to use" (p. 86).

I must add that, as previously stated, I came awfully close to drinking about two weeks before starting the step process. Therefore, my sponsor told me that I could not rely on my mind to put truth on paper—after all, didn't my mind almost lead me into a bar just two weeks before? He pointed out that I had a dishonest mind. He also said that he thought I was silly as a pet coon which I did not like very much. Ha.

I think it is important to realize that to follow the Big Book Step Eight directions I needed to realize that the Steps are in order for a reason. If I would have followed the temptation to make an amends list out of order, it would not have been nearly so effective. I would not have followed the Big Book's "*clear cut directions*." (p. 29) I continue to thank God for providing me with a sponsor dedicated to the true AA program of action.
