For the newcomer, the first 164 pages of the Big Book contain the framework of how to overcome the disaster of a life consumed by Alcoholism. As I drank myself into the corner of life and ran out of options, I desperately searched for answers and something told me to try Alcoholics Anonymous and there I found People who had overcome most of the troubling issues of life. Each chapter has a certain subject and they try to explain specific areas of our lives where we could improve our thoughts and behaviors. It seems that if we did what they suggested in those 164 pages everything would be fine with us alcoholics; but wait! Next, they published The Twelve Steps and Twelve Traditions to give more amplifying information as to how to incorporate the steps into our daily lives. As I continued to progress in the program it caused me to seek a vastly more serious understanding of the depth of this disease and how serious my symptoms were. The first 164 pages just scratched the surface, but they gave me a challenge as to what degree of commitment I would pursue as I began to uncover defect after defect in a Thousand Facets of my sick mentality. Fear, insecurity, and my EGO dogged my every step and as I become strong enough to overcome my Ego driven approach to these issues my Conscience started getting a foothold and It motivated me to dig deeper yet and pursue a life based on unselfish Principles and to abandon the faulty thinking of the past. As I continued to grow, I had to come to terms with the understanding of a Power greater than myself and I was encouraged to read a book by Emmet Fox entitled "The Sermon on the Mount" considered to be the inspiration that the founders of the A. A. program incorporated into the Spiritual Solution to the doubters like me, and it removed all those doubts. Next, I had to learn how to become a good Husband, Father, Friend, Coworker, and so on. As we share our experiences with each other we are in the state of learning how to solve those Thousand Facets of our sick mentality. My wife came home from an AI Anon meeting, in my early years of sobriety, all excited about the topic of "Examining our Motives. That one little statement changed my entire way of thinking about my behavioral problems. Selfishness---Self-centeredness! That, we think, is the root of our troubles. (BB pg.62) If selfishness is the root, (motive) then unselfishness is the obvious solution. That simple understanding set, in place, a habit of living by unselfish motives and as a result, I am not ashamed of anything I do today, I have a clear conscience, and it is so much easier than I thought it would be. It doesn't say generous, it just says unselfish. DUH! The world is full of supporting information concerning all the facets of the different mental troubles the alcoholic is faced with when seeking answers. When we use the word, Love, I thought it was a feeling, but I found a version of Love in a book by Scot Peck's, The Road less Traveled that defines Love as: Caring for and Nurturing another Person's Soul. It is an action word and I can Love everyone even if they don't love me back by sincerely wanting the best for them and offering my help. Using these examples is my way of encouraging everyone who finds it difficult to experience the quiet satisfaction that they expect to receive from the program, to find the answers by looking deeper into the subject and seek out the answers that help you to set, in place those unselfish Principles and Habits which lead to, as an old friend refers to as, Peace of Mind and a Quiet Heart.

Tradition One:

Our common welfare should come first; personal recovery depends upon AA unity.

The definition of unity according to the dictionary is "joined as a whole". In mathematics it is the number one. Welfare is defined as "the health, happiness and fortunes of a person or a group".

It says in the Twelve and Twelve that "the unity of Alcoholics Anonymous is the most cherished quality our Society has. Our lives, the lives of all to come, depend squarely upon it. We stay whole, or A.A. dies. Without unity, the heart of A.A. would cease to beat; our world arteries would no longer carry the life-giving grace of God; His gift to us would be spent aimlessly."

When I think about Tradition One, I think about looking for the similarities not the differences, putting principals above personalities and our singleness of purpose. There are some very strong words and phrases in the quotes above about the importance of unity that remind me that my survival is dependant on the existence of the groups of A.A....cherished, future lives depend on it, A.A. would cease. To lose a cherished part of my life that would also affect the future of others as a result of the death of A.A. is unthinkable. Because of the unity of A.A. created by our singleness of purpose I am welcome at any meeting anywhere in the world. I am assured the same consistency of message...one based on the principals of the program of A.A. Regardless of our individual resumes, we are the benefactors of a Higher Power who has united us with a singleness of purpose for the greater good of our society. Nothing else matters...and it has stood the test of time. I want my behavior to be reflective of the unifying message that sustains me one day at a time.

Tradition One Checklist

Tradition 1 checklist: Our common welfare should come first; personal recovery depends upon AA unity.

- Am I in my group a healing, mending, integrating person, or am I divisive? What about gossip and taking other members' inventories?
- Am I a peacemaker? Or do I, with pious preludes such as "just for the sake of discussion," plunge into argument?
- Am I gentle with those who rub me the wrong way, or am I abrasive?
- Do I make competitive AA remarks, such as comparing one group with another or contrasting AA in one place with AA in another?
- Do I put down some AA activities as if I were superior for not participating in this or that aspect of AA?
- Am I informed about AA as a whole? Do I support, in every way I can, AA as a whole, or just the parts I understand and approve of?
- Am I as considerate of AA members as I want them to be of me?
- Do I spout platitudes about love while indulging in and secretly justifying behavior that bristles hostility?
- Do I go to enough AA meetings or read enough AA literature to really keep in touch?
- Do I share with AA all of me, the bad and the good, accepting as well as giving the help of fellowship?



Concept One

CONCEPT 1

" The final responsibility and ultimate authority for A. A. World Services should always reside in the Collective Conscience of Our whole Fellowship"

This concept follows closely the guidelines of the 2nd Tradition, which states, " For our group purpose, there is but one ultimate Authority- A Loving God as He may express Himself, in Our Group Conscience. Our Leaders are but trusted servants; they Do Not Govern"

In 1948, Bill and Bob wisely foresaw the need for a World Service structure. They, along with early members, agreed for a Board of Trustees to be appointed. They were to be tasked with creating and printing uniform Literature, including a Monthly Newsletter. And to create a Sound Public Relations Policy, and put in place guidelines and framework to support groups that were sprouting up Worldwide.

In the ten years since our humble beginnings, membership had grown from 50 members, to over 100,000 throughout the World.

The shocking and sad news of Dr. Bob being terminally ill, drove home the fact that Our Founders were mortal, and therefore perishable. It was clear that this new Entity would need to be self-sustaining, comprised of a rotatable group of trusted Servants. In order to be successful, it would need to grow and change with the needs of World Membership.

Originally named the Alcoholic Foundation, it was renamed the General Service Board of Alcoholics Anonymous, in 1954. This was shortly before the 1955 International Convention, in St. Louis. It was there that Bill W. transferred the responsibility for World Services to the Entire Fellowship.

The idea of calling together delegates from around the World was met with much resistance from many early members. Concerns that politics, confusion, great expense and fruitless strife would surely be the outcome of such a Calamitous Event. There were many divided and conflicting opinions, as to how We should proceed. Yet here we are, today, after six decades of Great International Conventions, reaping the benefit of the foresight and wisdom of Our Founders. Seeing it come to Fruition, every Five years !!

THE GREAT REALITY DEEP WITHIN

I believe I am—as are we all—endowed with a powerful Truth that can potentially envelop our false ego that tells us to drink. The Big Book tags it as: "*The Great Reality deep within.*" (p. 55) Some think of this spirit as "Soul" or "God Self." This True Self has the benevolent potentiality to encompass and overcome our false *ego-driven* self. This Great Reality could be thought of as an OVERSELF, if you will. However, this remarkable blessing is manifested only so long as alcoholics remain in a fit spiritual condition. (p. 85)

It has become AA cliché: "*An alcoholic cannot drink on the truth—only on a lie.*" My false self usually believes what it wants to believe regardless of anything that stands in the way of that first drink—it has the unique capacity to believe a lie, *even* when it knows it's a lie. The Big Book calls this: "*alcoholic insanity.*" (p. 9) For me, this resulted in twenty-four unsuccessful years of 'quitting drinking forever.'

However, after a year or so of living in the *spirit* of the Twelve Steps, this Great Reality (Overself) magically enveloped (ate) my false ego self. Now drinking alcohol no longer remains in my emotional vocabulary! Seemingly gone! As the Tenth Step promise, promises: The problem (mental obsession) has been removed! (p. 85) (Removed yes, but still lurking!)

Possible explanation: Just as darkness cannot penetrate the light, a lie (mental obsession) cannot penetrate the Truth. In a word: "***The True Self gobbles up the false self and sets us free.***"
