Dear Salt River Intergroup Community:

First, the SRI Steering Committee wants to extend our thanks for your continued support of SRI Steering Committee and SRI Central Office. 2020 has been an interesting and challenging year. We've been pushed to be creative, proactive and strategically focused in order to ensure our ability to carry the message to alcoholics. Who knew ZOOM meetings would become such a vital lifeline for our recovery? Who knew COVID-19 would cause so many of our recovery gatherings to be cancelled? Absolutely amazing! Yes, we have collectively been "tested" about GOING TO ANY LENGTH!!!

As has become our practice, the SRI Steering Committee wants to continue to provide **transparency** to our SRI Intergroup Community. Thus, the following information is being provided:

• SRI Steering Committee heard your concerns about COVID and not wanting to participate in social gatherings. As a result, we requested our 2020 Summer Round-up be vacated. As of June 1, we have received confirmation from our attorney, after discussions with the DoubleTree Resort By Hilton Hotel Paradise Valley Scottsdale, the 31<sup>st</sup> SRI Summer Round-up has been **cancelled WITHOUT financial penalty**! The written communication "confirmed that our contract is unconditionally cancelled."

• As of June 2<sup>nd</sup>, we have submitted a written request to the Resort asking for **the 2<sup>nd</sup> weekend in August (August 13-15, 2021) for our 31<sup>st</sup> Annual SRI Summer Round-up.** 

• The SRI Steering Committee wishes to thank Les R. and the 2020 Summer Round-up Committee for their hard work and dedication in planning done so far. Les and the 2020 Summer Round-up Event Committee will continue in their current roles for 2021.

• The SRI Steering Committee continues to conduct business, as usual, via ZOOM. Our focus is on ensuring the doors of Central Office remain opened and that we can effectively continue carrying the message to alcoholics. Finances are being monitored and adjustments made to keep us financially solvent. As you recall, during COVID-19, Central Office was closed due to the Governor's Executive Order. As a result, we have lost approximately 75% from sales income. This, combined with the income lost from not having a 2020 Summer Round-up, WILL make 2020 a very financially tight year. Simply put, WE NEED YOUR INDIVIDUAL AND GROUP CONTRIBUTIONS NOW!!! WE NEED YOU/GROUPS TO PURCHASE ITEMS FROM CENTRAL OFFICE!

• While SRI Central Office qualified for the **Paycheck Protection Program (PPP)**, both the SRI Steering Committee and SRI Intergroup voted against keeping these funds. We voted to continue within our Bylaws, GSO Guidelines and AA Traditions.

As GROUPS are shifting from **ZOOM meetings back to in-person meetings**, we request you update SRI Central Office on your meeting status. We want to continue to provide correct information on the SRI Website. To update your meeting information, please email <u>suspend@aaphx.org</u>

• SRI Central Office will remain open for business **Monday-Friday 9am to 6pm.** At this time, due to continued COVID concerns, we will request customers please **wear face masks and practice social distancing.** 

• June Intergroup Meeting will be conducted by ZOOM. As we prepare for the 2020 Elections of Steering Committee (November), it is vital Groups participate in 3 of the 6-month Intergroup Meetings in order to qualify to vote in this election. To prepare for this, we ask each Intergroup Representative sign into the Zoom meeting by first name AND Group Name. This will allow us verification of attendance. If you are an Alternate, please list that as well so that we can separate if both the Intergroup Rep and Alternate are present and only count one. Central Office will be emailing out our Business Meeting Agenda, materials and sign-in information.

Finally, on behalf of the SRI Steering Committee and Central Office, we extend our thanks and appreciation for all that you are doing to support SRI. We value our relationships with you and our membership. We embrace the power of our fellowship and gifts of our recovery!

- 4. Should the secretary of our group serve on the mayor's advisory committee on alcoholism?
- 5. Some alcoholics will stay around AA only if we have a TV and card room. If this is what is required to carry the message to them, should we have these facilities?



## **Concept Six**

On behalf of A.A. as a whole, our General Service Conference has the principle responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognizes that the chief initiative and the active responsibility in most matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous.

Much like we trust our GSRs to take our group conscience to the Conference, the Conference itself delegates authority to its Trustees to carry out and implement decisions. They have a great deal of responsibilities, and are an integral and important part of A.A. World Services. They are the key players in the operations of publishing, General Service, and the Grapevine, Inc.

Guardians and Bankers of large sums of money, they are tasked with it's wise use in conducting A.A.s Worldwide affairs. They oversee investing and everyday operations of virtually every aspect of A.A. business. Coordinating with the Reserve Fund, they are like Directors of a Holding Company. One which owns and controls two subsidiaries ; A.A.W.S. and The Grapevine, Inc.

They are a select, experienced, and powerful group of trusted servants. They are chosen wisely, and well vetted, as A.A.s management and success in " carrying the message " Worldwide, is their primary responsibility.

### **Open Meeting with Welcome, Mission Statement and Serenity Prayer**

#### Introduction of the Steering Committee – Absent: Paul

New Intergroup Reps - None identified tonight.

#### Remarks and Announcements by the Chair – Robbin

**Treasurer Report – James** – Pages 6-7 of the Agenda Packet. James outlined the current fiscal situation and some of the projections he has put together with Central Office. This was outlined in an email the text of which is below.

April and May rent was paid in full. We are currently in conversation with the landlord.

#### **Treasurer Projections**

I can get quite granular with the numbers, but I thought some rounded to the \$100's with averages would paint a pretty clear picture.

- Current bank balance \$59,200
- Current checking \$19,200
- Prudent reserve \$40,000
- Avg.Monthly expense \$11,200
- Avg.net Income -25% \$5,400
- Avg. monthly loss -\$5,800 (burn rate)

• Without adjustments to expenses and a 25% downturn in sales and contributions, I project we will be into the prudent reserve by August 1st.

• Without adjustments to expenses and a 25% downturn in sales and contributions ,I project we will burn \$40,800 by the end of 2020.

- Without adjustments to expenses and a 25% downturn in sales and contributions ,I project we will be insolvent by 4/1/2021.
- Insolvent means defaulting on the lease and shutting doors.
- It will be close, but the Alcothon requires \$12,500 capital to put on. We did receive \$11,400 in income last year. So it was a little more than a \$1,000 loss. Not sure if the thought process is a decrease in projected income due to smaller attendance. We will be in the last \$20,000 of the prudent reserve by that time.
- With this projection the major point I am taking not only keeping the doors open but the feasibility of having the cash on hand to put on the 2021 round up.

It is my opinion that with or without the PPP we will need to have discussion and a plan of action for a restructure in order to remain solvent with the capital on hand to produce the 2021 round up, that then we can begin the rebuilding process.

After tomorrow nights meeting will have a decision on the PPP from the members and we can then move forward with the budget projections we have, and begin to analyze and move to our next action.

You never know... the life you save just might be your own!!! If interested, please let me know! I can be reached at (602)264.1341.


## <u>Please remind groups to buy literature & chips from SRI office to help support your local AA Intergroup</u> so that we can keep the hand of A.A. there for all who need it.

legal advice to represent our contractual interests in this matter. We are keen to maintain and improve our relationship with the Doubletree but not at the expense of the fiscal safety of our membership. We have committed a \$1000 retainer to draw down upon in the use of services. We can confirm that the attorney will be cancelling the August date.

#### Attorney/Client Privilege

This is a sacred trust held by the client. This essentially means the lawyer cannot divulge what has been shared by the client. The client can, however, waive privilege by sharing legal details in an outside conversation. Therefore, the legal 'game plan' will be held close to the chest of those that need to know.

Are there any prospects for a fund raising activity? Any and all creative ideas will be gratefully received!!

So much discussion was undertaken around the fiscal situation and ways to ameliorate it.

### Anniversary Raffle Update

#### New Business

**PPP** – Quianna – outlined the timeline that brought us to where we are with the PPP scheme. PPP must be distributed as 75% toward payroll, 25% can be used on rent and utilities in order to be a grant. To use it otherwise would automatically transfer it from a grant into a loan. If we return it, the money needs to be sent back by the 14<sup>th</sup> May.

SC asked themselves and said 'are we even eligible for PPP?'. Office Manager got the information about qualification for PPP. We then discovered the funding had run out and our application wasn't even processed as we knew. More funds became available and those applications that were hanging about were processed and monies were disbursed. A human error occurred and the funds were accepted. As a Steering Committee we then discussed, at length, the fact that acceptance of this was a contravention of Tradition 7. SRI Bylaws Article 5 state: the activities of the intergroup shall be financed primarily by the groups and secondarily by literature sales, special events and direct donations from A.A. members.

No contribution of any kind from sources outside of Alcoholics Anonymous will be accepted.

Much discussion was undertaken.

Marilyn motioned: To return the PPP money as per the 7<sup>th</sup> Tradition. Dave B seconded. Aye – 24 No – 4 Abstain – 1. Minority opinion. I believe that we are rushing this because of the deadline that the money will be used otherwise. Money is intended to keep salaried workers employed. I feel that there is time to amend the bylaws to specifically address the issue. We would only be using this money to keep the IG vibrant and the doors open. The sadness of not keeping this money and using it to retain our staff would be enormous. I believe that we should make an emergency amendment to the bylaws to address the Covid 19 issue. I believe this would substantially assist. I don't believe it is an outside contribution and we need to keep the doors open. Motion carries.

Many participants thanked the Steering Committee and the Central Office staff for their hard work and due diligence.

Motion to close: Chuck. Seconded: Tom Unanimous acceptance.
