From Your Steering Committee

Tradition Eight

Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers.

"Because it has now become plain enough that only a recovered alcoholic can do much for a sick alcoholic, a tremendous responsibility has descended upon us all, an obligation so great that it amounts to a sacred trust." Bill W, 1948 letter to the Grapevine.

Tradition Eight, the long version, tells us "... we may employ alcoholics ... to perform those services for which we might otherwise have to engage nonalcoholics." Our staff at SRI's central office come to work every day to coordinate, organize and facilitate the operations of that office. They manage sales, input information, provide records, inventory literature, order supplies and equipment, enable special events and phone answering, and much more. They need not Dave B. be alcoholics to perform these important functions. Many non-alcoholics are capable office managers, data entry personnel, etc. I enjoy pitching in for an hour or two on occasion. But every day? Without pay? So, our staff is paid to provide daily support to over 300 groups so that recovered alcoholics in the Phoenix, Scottsdale & Tempe areas can carry a message that "can do much for a sick alcoholic."

Well, why not me? I spend much of my time helping

sponsees through their Steps; being available to make and take calls; helping people move, driving them to meetings or to get groceries, caring for their pets when they're gone; meeting for lunch or coffee. I listen to newcomers when friends and family won't. I hear them when no one outside of AA can. I speak with them in ways they understand.

I came to AA years ago, begging to have the obsession and compulsion to drink alcohol removed. It was removed. I was paid in full. Loving sponsors walked me through the life-changing Steps, and guided me on a path to "release from care, worry and boredom." I was paid in full. My life today is full of fellowship and purpose. I carry "a sacred trust" that was freely given to me. I give it freely to others because I have already been paid in full.

Question:

Do I sometimes try to get some reward—even if not money -for my personal AA efforts?

Tradition Eight Checklist

Alcoholics Anonymous should remain forever nonprofessional, but our services centers may employ special workers.

- Is my own behavior accurately described by the Traditions? If not, what needs changing?
- When I chafe about a particular Tradition, do I realize how it affects others?
- Do I sometimes try to get some reward-even if not money- for my personal AA efforts?
- Do I try to sound in AA like an expert on alcoholism? On recovery? On medicine? On sociology? On AA itself? On psychology? On spiritual matters? Or, heaven help me, even on humility?
- Do I make an effort to understand what AA employees do? What workers in other alcoholism agencies do? Can I distinguish clearly among them?
- In my own life, have I any experiences which illustrate the wisdom of this Tradition?
- Have a paid enough attention to the book Twelve Steps and Twelve Traditions? To the pamphlet AA Tradition-How It Developed?



Concept Eight

The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporat- ed and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities.

Concept 8 addresses the potential dangers of too few people taking on too many tasks. Bill W. warned against "too much *concentration* of money and authority," based on early AA experiences.

The General Service Board is not directly involved in the daily operations of the General Service Office or AA publications. Instead, those tasks are delegated to others, such as the office manager. This allows the Board to focus on larger questions of policy, finance, group relations and leadership. Taken from the 2020 Filing Cabinet

Steering Committee Member Spotlight

Five Familiar Phrases

Each Alcoholics Anonymous group ought to be a spiritual entity *having but one primary purpose*—that of carrying its message to the alcoholic who still suffers.

Recently I took a closer than usual look at Tradition Five. Five familiar phrases make up this tradition. Being the grandiose alcoholic I am, I decided to write a college textbook on each phrase. Then sanity returned. So here is a passing glance. But I encourage you to further explore and discuss them in your group.

Alcoholics Anonymous group

If you're reading this, you surely attend one or belong to one. Our Third Tradition (Long Form) tells us precisely what one is. Tradition One tells us why we need one. [See Suggested Readings below]

spiritual entity

The Oxford Dictionary defines 'entity' as "a thing with distinct and independent existence," and 'spiritual' as "relating to or affecting the human spirit or soul as opposed to material or physical things." Thus, Tradition Five is asking every AA group to be a thing that exists to affect the human spirit.

carry its message

Much has been written about the AA message. There is even a 164-page volume devoted entirely to it! The message, of course, is that there is recovery from alcohol through the Big Book and the Twelve Steps of AA. Experience has taught us that recovery is "...the result of these steps,.." Pages 89 – 103 of that same volume tell us how best to carry it.

the alcoholic who still suffers

This phrase applies most importantly to those who are still actively engaged in alcohol abuse and want help to stop drinking. It can also apply to those of us in early recovery, sometimes fighting the urge to take that first drink. It can apply to any of us at any time, dealing with life on life's terms. "After all, our problems were of our own making. Bottles were only a symbol." Thus, herein, the Fifth Tradition fulfills the First Tradition, strengthening both the group and personal recovery. [See Suggested Readings]

Finally, the *ONLY italicized* phrase in all the Traditions (Long or Short)

but one primary purpose

Again, the Oxford Dictionary. 'But', as an adverb, means "no more than; only." 'Purpose' - "the reason for which something is done or created or for which something exists."

I remember an old-timer telling a group of us, mostly new, that the fifth tradition is the hub of a wagon wheel, the core of AA. "Wouldn't that be the twelfth tradition?" someone argued. "That's a "how to...," she replied. "Six through Twelve are all how to do what we do, but number Five is what we do."

We know we have many responsibilities necessary to make our fellowship function, too many to list here. Some are addressed by other Traditions. Most or all can be found in The AA Group booklet and/or pamphlet listed below. None are an end goal; they merely facilitate our reason to exist.

Another longtime member, whose article was published in Our Twelve Traditions [Suggested Readings], says it like this: "Because of the Fifth Tradition, we are free of the necessity of raising large sums, or trying to change society. It is not our purpose as AAs to educate children about drinking, nor to teach the medical profession or the government about alcoholism. These might be side effects or spin-offs of what we do, just as a network of enjoyable and therapeutic social activities may also result from AA life. But they are not our chief purpose; they are subordinate to our goal of staying sober and helping others."

So, it can be said, the AA group is a spiritual entity whose main reason for existing is only to touch the human soul by bringing "the AA message to those who don't know there's a way out," one alcoholic talking with another. But perhaps our Fifth Tradition says it well enough. Dave B


