### **Tradition Twelve**

Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities.

When I got to AA, principles before personalities was easier for me to get my arms around than anonymity. I didn't care when I got here about keeping my own anonymity; I was coming out of incomprehensible demoralization and I wanted life! I remember however, the sense of humility that moved in me as I truly understood I had been given new life. Now yrs. later, I am grateful for the opportunities to learn as I work the principles in all my affairs. I agree that understandable humility, in action, is what saves us from our ego self, allowing the spirit of Unity in and allowing us to safely carry the message to another suffering alcoholic. There is no need to know my name or bring attention to myself. There is no need for me to name others, breaking their anonymity. All of that would be a distraction from the lifesaving message within principles before personalities.

### **Tradition Twelve Checklist**

- Have I a personal responsibility in helping an AA group fulfill its primary purpose? What is my part?
- Why is it a good idea for me to place the common welfare of all AA members before individual welfare? What would happen to me if AA as a whole disappeared?
- When I do not trust AA's current servants, who do I wish had the authority to straighten them out?

### **Concept Twelve**

"The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle: that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and whenever possible, substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government; that, like the Society it serves, it will always remain democratic in thought and action. (short form)."

Of all the concepts, this is probably my favorite because of the 'General Warranties'. Webster defines 'warranty' as a statement of promise or a written guarantee. Some in the fellowship see the Warranties as the "A.A. Bill of Rights' for the membership. The basic principles found in each warranty apply to our home groups as much as they do to the General Service Conference itself. The principles of the 6 vital warranties that this Concept contains help to bind the Conference to the grassroots of A.A. by acting as a check against the natural desires for wealth, power and prestige. Bill W. called these warranties counsels of prudence. They can also be seen as representing sacrifices we all have to make in order to get along and carry the message. In this sense they are like the 12 Traditions, and like the Traditions they can be applied to A.A. services at any level.




