Tradition 7

Every A.A. Group ought to be fully self-supporting, declining outside contributions.

There are well-defined, valuable suggestions for how groups can take in and disperse funds to support themselves and to carry the message of Alcoholics Anonymous as they see fit. [See Suggested Readings]

But how can the Seventh Tradition benefit us personally?

Responsibility. As active alcoholics we were takers. We put our needs before the needs of others, especially our loved ones. How many times did I hold money back for a drink, or spend lavishly drinking with my friends, only to find, in the light of day, that my bills or my family's needs could not be met? How many times did I beg, borrow or steal for a drink? "Selfishness—self-centeredness! That, we think, is the root of our troubles." Giving whatever we can to a basket or can at each meeting slowly, but surely, helps us pay our own way. It allows us to feel a sense of worth, to be able to say "I am responsible". This is the principle of Tradition Seven.

Integrity. As active alcoholics we were amoral at best. Too often, our behaviors did not match our values. How many times did I betray my own truths in order to drink? Lies, justifications, self-deceit. When we come to AA, we hear "do the next right thing". What does this mean? It means that if we wish to regain a moral compass, to restore trust in ourselves, we must repeat actions that match our values. We value what our AA group does for us. We do not wish to see issues of money, property, or outside enterprises interfere. So, we contribute to the group because it is the right thing to do.

<u>Gratitude</u>. As active alcoholics we felt the world owed us – sympathy, money, opportunity, respect, etc. We were always unsatisfied. How many times did I drink at not getting something I thought I deserved? The simple act of contributing to that which is helping us (and others) stay sober can, in time, reverse this attitude and give us a sense of spiritual satisfaction. We begin to realize that we are blessed with something far greater than money can buy. Thus, our financial support becomes an outward expression of a deep inner gratitude.

Concept 7

The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

This concept may appear to be contradictory; it may look like the collision of an irresistible force with an immovable object. On the one hand we see a Board of Trustees which is invested with complete legal power over A.A.'s funds and services, while on the other hand we find that A.A.'s General Service Conference is clothed with such great traditional influence and financial power that, if necessary, it could overcome the legal rights of the Board of Trustees. It can therefor give the Trustees directives and secure compliance with them-practically speaking.

A number of ideas and concepts were thought of to maintain a balance between the Conference, the Delegates who represent all areas and the Board of Trustees, which is made up of alcoholics and nonalcoholics were abandoned. So a Conference Charter was developed which gives Conference a final and ultimate authority and legally preserves the right of the Trustees to operate like any other business board of directors. Now there is balance maintaining "group conscience" conforming with Traditions one is protected by tradition and the other by law.

Hi all,

This last month I attended the Pre-Conference area 03Assembly in Lake Havasu and the Maricopa County District 08 DCM meeting. Here are some main highlights.

Pre-Conference Assembly:

- * A revised budget was submitted and approved with a line item explanation given for each revision. Every attempt is made to balance the budget. However, due to our area treasurer passing away and sorting out those financials still being realized as they are discovered and the complexities around that, the approved revised budget has a shortfall of (\$4,712.40). There will be some further adjustments for approved increased AV (Hybrid) expense for the next 2 assemblies.
- * Kathy, our delegate, gave a very comprehensive report of her attendance at the 73rd General Service Conference. Please see her 86 page report at area03.org. for more detailed information. A few takeaways were:
- 1) For the 2035 International Convention only three cities remain for consideration: Phoenix, Indianapolis, New Orleans
- 2) The General Service Board has been questioned extensively about the board accepting the GSB Chair's resignation. The Chair position will remain vacant for a year.
- 3) GSO has a floating reserve fund of 9 to 12 months. Our Delegates report reaffirmed the twice previously reported GSO reserve fund shortfall. The reserve fund is at 7 months.
- 4) Grapevine and La Vina- costs are up, subscriptions are down and there is much review and attention to this financial conundrum.
- 5) Kathy reviewed the plain language translation of the BB and put some examples in her report.

- preside at all meetings of the Steering Committee and the Intergroup;
- see that all decisions and resolutions of the Steering Committee and Intergroup are carried out:
- execute, in the name of the Intergroup, all contracts and other documents affecting
 the Intergroup with of approval of a quorum of the Steering Committee and/or the
 Intergroup via email or monthly meeting;
- appoint, subject to the confirmation of the Steering Committee at the next regularly scheduled Steering Committee meeting, all Event Chairpersons, and all Chairpersons of Standing Committees;
- create ad hoc committees to carry out special projects of a short term nature, and may appoint, subject to the confirmation of the Steering committee, the Chairpersons of such committees:
- be the spokesperson for the Intergroup in all public matters and issues;
- has general oversight responsibility for the proper and effective conduct of all committees, and may recommend removal of any Chairperson from any Committee or Event to the Steering Committee; and,
- Appoint a Parliamentarian for the Intergroup meeting in the absence of the Immediate Past Chairperson.

Vice-Chairperson: Five (5) years of continuous sobriety. Term is 1 year.

Advisor: Three (3) years of continuous sobriety. Term is 2 years.

- attend and participate in Steering Committee meetings;
