We welcome women to **Sisters in Sobriety** (SIS) on Tuesdays from 5:30 - 6:30 p.m. at Echo Mountain Church, located at 19051 North 20th Street in Phoenix, AZ, 85024.

Type of Meeting

SIS is a Closed Women's Meeting of Alcoholics Anonymous

SIS is a topic-discussion meeting except for the first Tuesday of the month when we read and discuss the month's corresponding Step from AA's <u>Twelve Steps and Twelve Traditions</u>. For the topic-discussion meetings, SIS invites women celebrating a sobriety milestone to share and choose a topic. Tickets are drawn for additional women to share about the chosen topic.

How are Sisters in Sobriety Carrying the Message to Others?

Sisters in Sobriety carries AA's message by rallying around the newcomer and each other with unconditional support. We show newly sober women how to participate in keeping AA alive with our strong home group and well-attended business meetings. One of our SIS service positions is Newcomer Ambassador, ensuring that new women get attention, time, literature, and phone numbers. New members are asked to participate in service right away by giving out meeting tickets, setting up for the meeting, or greeting.

In order to carry the message in fellowship with AA as a whole, SIS supports service representative positions such as GSR, SRI, H&I, PICPC, and Alternates for each. Rotating positions offer opportunities to all who wish to be part of SIS. In this way, SIS provides a fellowship for our individual recovery, works toward and achieves group unity, and absolutely thrives on service.

What's Exciting About SIS

At SIS, we are each other's cheerleaders and teachers all along our sober journey. We are confident each other is aligned with our primary purpose, which is to stay sober and help other alcoholics to achieve sobriety. We communicate well and respect each other's experience, strength, and hope. Fellowship after the meeting allows our group to forge an even stronger bond.

One member put it this way, "Like many newcomers, I was on a bumpy road when I first attended SIS. I struggled with a power greater than myself. The women of SIS taught me that I was not alone. I am beyond grateful that the women of Sisters in Sobriety always accept me no matter where I am in my journey."

At SIS, whenever we see someone struggling, we reassure them that every woman's journey is her own and that individual peace, strength, and success continues to happen within the strong bonds of our home group, Sisters in Sobriety.

Tradition Five

Our primary purpose is to stay sober and help other alcoholics to achieve sobriety. Tradition Five extends the primary purpose to the groups. How does your group carry the message? Each group will do this a bit differently. Some groups will host an H&I meeting for the confined alcoholic, others are sure to have a kid's room, so there is a place for the alcoholic who needs to bring their child. Another group may have a newcomers table at the meeting or hand out a newcomer packet that includes phone numbers of their members. At another meeting, there may be a greeter at the door who introduces a new person to others in the room.

My first meeting was a whirlwind. I sat in the back of the room just shellshocked. Ashamed and embarrassed to even be there. It was a speaker meeting where someone was chosen to share their experience strength and hope for about 15 minutes, and then the room was welcome to share on a topic. I didn't know what to expect, but what I found made me feel ok staying for that hour and then returning the next day, and the next day and the day after that. I remember the chairperson reminded everyone to *Listen for the similarities and not the differences.* Over seven years ago and I remember who the chairperson was, them saying that phrase, and who the speaker was. Before I left, I was approached and given a little red book and a newcomer's packet. I combed through that packet that evening and I didn't drink.

What was your first meeting like? Do you have a home group now? How does your group welcome new people? Is it something you do together in a conscious way or is it left to chance? I like to think the answers to the questions don't really matter, but the growth that happens when we think about and act on it, does matter. It's through our efforts to help another person that we build our new lives. What do we want that new life to look like?

- Have I today imposed on any AA member for a special favor or consideration simply because I am a follow alcoholic?
- Am I willing to twelfth-step the next newcomer without regard to who or what is in it for me?
- Do I remember that AA old-timers, too, can be alcoholics who still suffer? Do I try both to help them and to learn from them?

"These Twelve Concepts therefore represent an attempt to put on paper the why of our service structure in such a fashion that the highly valuable experience of the past and the conclusions that we have drawn from it cannot be lost" – Bill W. 10th General Service Conference -1960 New York, New York.

Concept 5

"Throughout our world services structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered. "

We all get together, carefully consider the proposed idea, discuss the pros and cons, and finally vote on the matter, reaching substantial unanimity (at least 2/3 of total votes.) Done deal, right? HOLD ON.

This Concept gives the minority (those who voted on the losing side of a proposal) a chance to speak up after the vote has been taken. Why? The minority frequently is right. Even when in error, the minority can ensure a thorough debate on important issues. The well-heard minority, therefore, is our chief protection against an uninformed, misinformed, hasty,

or angry majority. **Concept V** ensures all have a chance to be heard, thus preventing the majority from strongarming it's way to power. According to Bill "We shall never be subjected to the tyranny of either the majority or the minority, provided we carefully define the relations between them and forthwith tread the path of world service in the spirit of our Twelve Steps, our Twelve Traditions, and our Conference Charter."



One person starts by reading a paragraph or two and then can share for a minute or two what has been read or they can simply pass to the left for more readers. As the reading goes around the room from person to person there becomes more of an opportunity for the current reader to share for a couple minutes anything that has already been read.

On the last meeting of the month, we celebrate AA anniversaries with a cake, and a speaker. The longevity of sobriety is phenomenal with members in very early sobriety going all the way up into the 40s and 50s milestone count. The willingness to rally around the newcomer is such a beautiful space to be involved with.



Hi everyone,

I attended PRAASAA as your representative in March. The stated purpose of PRASSA is: To develop greater unity among members, groups, and areas of the Pacific Region; encourage the exchange of ideas and experiences. To provide an opportunity for members to discuss pertinent aspects of AA. The Assembly and The PRASSA Committee should always foster the Recovery, Unity, and service legacies of AA.

I brought back a thumb drive of PRASSA and left it at the SRI office, so it is available. I also have it downloaded on my computer for reference so if you want to hear more in-depth goings on for the whole weekend, it is available via the SRI office or by contacting me.

Some highlights

- Our Delegate Blas A presented the timeline history of the evolution regarding the publication of a plain language translation of the Big Book. This began in 2016 at the General Service Conference and has been discussed by the GSC since that time.
- I attended both the GSR and Intergroup Roundtables. The topics discussed that seemed to have the most interest was: How to best achieve an informed group conscience. When to use the right of decision. Methods to encourage GRP participation. Traditions and Concepts understanding and adherence or lack thereof. Intergroup funding. Intergroup organization via boards, charters, or bylaws.

Grapevine/ La Vinia still have significant financial shortfalls.

GSO is conscientious in their endeavors to serve us.

The 2025 International Convention is in Vancouver, British Columbia, Canada, July 3-6th. My general takeaway from PRASSA was that AA is strong and members in general service are passionate about the welfare of AA and fulfilling our primary purpose. Communication and the flow of information with adequate transparency is unifying. Opposing views are normal and our discussion and vote method through representation works. The Traditions and Concepts of Service provides a marvelous framework for us to play in the sandbox together in service.

My other service endeavor was to attend the March district08 meeting. The main takeaways from the District08 meeting were:

- A fund will be created for up to \$100 per non-funded member of the distric08 committee or GSR with a cap of up to fifteen per year on a 1st come 1st serve basis to aid in attending PRASSA.
- District 08 will conduct an inventory during the 2nd yr. of each rotation in May. Participants will include district officers, coordinators, DCM's and GSR's. The result will be shared with the body at the next MCSM meeting following the inventory. The information can be brought back to the groups for discussion and input returned at the next MCSM meeting.
- A bid will be put in by District08 to host the 2025 state convention again at the Wigwam in Litchfield Park.
