Tradition 10

No A.A. Group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues – particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.

If each of our Traditions were lead singers, the Tenth Tradition would be their back-up band. Bill Wilson even called it our most "vital" tradition. Why is this?

As individuals, we AAs believe in issues strongly. Our highly sensitive emotional natures drive us to be deeply passionate about our beliefs. Our need to be right can easily overtake us. And, oh boy, do we like to carry judgments and grudges. In this, except for the highly sensitive emotional part, we are really no different than the general public. Unlike the general public, we voluntarily belong to a life-sustaining fellowship. In the fragmented world in which we live, how to sustain that life-giving force is the question. Within our worldwide fellowship there might be a thousand ideas about what the problem with the world is and 5 million solutions. So what can we AAs agree on?

We can agree that **unity** is essential for our personal survival. We can agree that God, not our leaders, will best design and direct our group purpose. We can agree that, though we get to run our group as we see fit, our **purpose** must be to carry a unified message of recovery to alcoholics who still suffer. Regarding our **message**, we can agree that using the A.A. name to endorse, finance or otherwise support a non-A.A entity or idea misrepresents A.A. and leads to distrust. Likewise, we are agreed that no one person, by affiliation or otherwise, should represent A.A. at the media or broadcast level. And we agree that none of us should ever receive pay to personally carry this message, lest it distort the message and destroy the messenger. Most importantly, we agree that within A.A. we are all equal, using the principles of our Steps and Traditions, instead of personalities, to guide our decisions.

Tradition Ten makes agreement possible. It allows us to have the broadest of membership guidelines (Trad. Three). It provides a safe haven when the world around us may seem in disarray. Tradition Ten teaches us to seek a common solution; to set our personal beliefs and opinions at the door so we can enter the world of the spirit when we walk into A.A.

Concept 10

Every service responsibility should be matched by an equal service authority — the scope of such authority to be always well defined whether by tradition, by resolution, by specific job description or by appropriate charters and bylaws.

Our service structure requires that each operational responsibility is granted the corresponding authority, so it may function effectively. Remember, Concept I establishes that this services structure is rooted in delegation from AA groups. Once a person assumes a role within the service structure, that person needs authority to carry out his/her duties.

Bill W. warned against withholding such authority when he stated "...when *delegated* authority is operating well, it should not be constantly interfered with. [Otherwise]those charged with operating responsibly will be demoralized." In consideration of this, AA has implemented multiple procedural safeguards that allow for corrections and reorganization. For instance; although trusted servants have authority to do their work and achieve their responsibilities, that said authority is <u>clearly defined</u>, it is rarely the final authority, and it does not go unchecked. - Appoint a Parliamentarian for the Intergroup meeting in the absence of the Immediate Past Chairperson.

Vice-Chairperson: Five (5) years of continuous sobriety. Term is 1 year.

- serve as the Liaison to the Area Assemblies; and,
