Examine My Motives for All That I Do. By Rick R.

If someone were to ask me what brought me to the doors of the Alcoholics Anonymous (A.A.) my answer would be: "Alcohol had got the best of me, I was desperately circling the drain, and I didn't want to die young". Not everyone that comes to A.A. has that degree of desperation. I got sober on October 15th, 1969 and that was just tion has been the answer to all those alcoholic before Alcoholics were being offered Rehabilitation clinics. Up to that point most of our members came here were looking for answers. The success rate at that time, according to the foreword to the second addition of the (Big Book), Alcoholics Anonymous, it says that 50% of those who came here looking for answers got sober and never drank again 25% got sober after a few relapses and stayed that way and the other 25% showed improvement. To me, 75% sounds like a surprisingly good ratio of success. The only requirement for A.A. membership is a desire to stop drinking. (Tradition Three) Not everyone who comes to A.A. from the Court System or from a Rehab environment has the same amount of desperation as those original members had. This does not mean that they are not invited, for we treat them with respect but a large percentage of them do relapse and we welcome them back with open arms so as not to be considered an A.A. failure and eventually many of them do stay sober. The depth of the desperation is often consistent with the depth of thoroughness a person is willing to go through as he takes the steps and when I was faced with this suggestion that I do a Fearless and Thorough Moral Inventory in the fourth step, I began to resist and did what I would call a shallow facade just to get my ticket punched. Being in the Navy at the time I was abruptly flown out to the western Pacific during the

Step Ten: Continued to Take Personal Inventory. Vietnam War and assigned to a tanker replenishing the fuel on ships in the Tonkin gulf Fleet and I had four months to think about what I was going to do on my returned home. My conscience told me to discard my original inventory and do it right the second time around. That I think, is what made the rest of this program easy for me. Being willing to take responsibility for all those disgusting behaviors of yesterday and to make restitubehaviors in the past. If we have completed a good 4th and 5th step and again on the 8th and 9th step, how do we approach the tenth step which suggest that we continue to take personal inventory and when we were wrong promptly admitted it.

> Early in my sobriety my wife came home from an Al-Anon meeting excited about the topic they shared. She said that "We should examine our motives for all the things we do" and that made perfect sense to me. I have been living a life based on Unselfish Principles and I am never finished examining my motives. All my out-side behaviors (short-comings) are the result of my thinking (motives) and so long as I am willing to continue this path it has taken all the fight out of me. Selfishness--self-Centeredness! That, we think, is the root of our troubles. Driven by a hundred forms of fear, self-delusion, self-seeking, and self-pity we step on the toes of our fellows. and they retaliate. (BB pg. 62) What a Profound statement! Living a life based upon Unselfish Motives has restored my self-esteem and the final and most important result is peace of mind. Never thought that would happen!!! This is my understanding of Step Ten.

Tradition Ten

Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy.

From the beginning, AA recognized that in order to maintain singleness of purpose, the fellowship would need to focus on helping other alcoholics recover. That would mean not engaging in outside issues that could dissuade someone from wanting to participate in the AA way of life. The spirit of Tradition 10 allows for private members to have their own relationships with outside issues but that those issues must be left outside of the meeting rooms of AA. One of the earliest examples of a program of recovery that failed due to taking part in outside issues was the Washingtonians. Due to their fragmentation over a variety of political and social issues at the time, the fellowship fell apart.

What Tradition 10 means for meetings and individuals is that their participation in outside issues should be kept outside of the meeting rooms. Members should also avoid discussing such topics during the meeting itself. If a meeting drifts off topic, it becomes the responsibility of the chairperson or home group members to guide the conversation back to our singleness of purpose. This also includes limiting flyers and pamphlets to AA related events and activities in order to avoid the appearance of endorsing something as a fellowship.

Question: Do I ever give the impression that there really is an "AA opinion" on doctors? Psychiatrists? Churches? Hospitals? Jails? Alcohol? Prescribed medications? Other drugs? Other 12 step programs? Vitamins? Al-Anon? The federal or state government?

Tradition Ten Checklist

Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy.

Do I ever give the impression that there really is an "AA opinion" on Antabuse? Tranquilizers? Doctors? Psychiatrists? Churches? Hospitals? Jails? Alcohol? The federal or state government? Legalizing marijuana? Vitamins? Al-Anon?

Can I honestly share my own personal experience concerning any of those without giving the impression I am stating the "AA opinion"?

What in AA history gave rise to our Tenth Tradition?

Have I had a similar experience in my own AA life?

What would AA be without this Tradition? Where would I be?

Do I breach this or any of its supporting Traditions in subtle, perhaps unconscious, ways?

How can I manifest the spirit of the Tradition in my personal life outside AA? Inside AA?



Concept Ten

Every service responsibility should be matched by an equal service authority — the scope of such authority to be always well defined whether by tradition, by resolution, by specific job description or by appropriate charters and bylaws.

Our service structure requires that each operational responsibility is granted the corresponding authority, so it may function effectively. Remember, Concept I establishes that this services structure is rooted in delegation from AA groups. Once a person assumes a role within the service structure, that person needs authority to carry out his/her duties.

Bill W. warned against withholding such authority when he stated "...when delegated authority is operating well, it should not be constantly interfered with. [Otherwise]those charged with operating responsibly will be demoralized." In consideration of this, AA has implemented multiple procedural safeguards that allow for corrections and reorganization. For instance; although trusted servants have authority to do their work and achieve their responsibilities, that said authority is <u>clearly defined</u>, it is rarely the final authority, and it does not go unchecked.

It is the month of October...a great time to look at Step Ten...in both the Big Book and the Twelve and Twelve. I have heard in the rooms that Steps Ten, Eleven and Twelve are the maintenance steps. I would like to suggest that these are the growth steps. Working Steps One through Nine has been a huge growth journey for me. Is it even possible that there is more growth...and that it can be even more exciting and revealing than what I learned in Steps One through Nine?

The Big Book tells me that once I have reached Step Ten, I have entered the world of the Spirit. It goes on to tell me that the next part of my journey, which should continue for a lifetime, is to **GROW** in understanding and effectiveness...it does not say maintain...it says grow. I now have the beginnings of a relationship with a Higher Power whom I choose to call God.

Step Ten..."Continued to take personal inventory and when we were wrong promptly admitted it"...tells me I will continue to use all the tools I have learned in Steps One through Nine repeatedly. It reminds me that I am not, nor will I ever be perfect. I use this Step every morning. I write a letter to God reviewing my yesterday and the day that is before me.

The Big Book says that "every day is a day when we must carry the vision of God's will into all our activities." The purpose of the Big Book is to help me develop a relationship with a Higher Power

so that I can be of maximum service to Him and others. It tells me that this thought must go on constantly with me. It even says this is a good use of my will power...when I am aligning my will with God's will for me. If I have followed the directions up until now, I am promised a God-consciousness...the beginnings of this vital sixth sense...for this is what will catapult me in to that Fourth Dimension where I can be happy, joyous and free.

And so, Step Ten keeps me focused on my thoughts, attitudes, behaviors and words...to be hyper vigilant on aligning all of me to God's will for me today. It is so easy for me to veer off this path and focus on everyone and everything else that goes on around me. When I do that, I am unable to hear God's voice or feel his nudges. By starting each day in conscious contact with God...looking at how I showed up yesterday and preparing for how I want to show up today...I acknowledge and accept God as my Teacher, Source and Guide.

The consistent and constant practice of Step Ten enhances my connection with God. It strengthens and fortifies my relationship. It increases my faith and trust in God. My relationship with God is the most important thing in my life today. I want to know what his vision is for me and Steps Ten, Eleven and Twelve will keep me focused on God and me.
